**RULES, REGULATIONS AND INFORMATION**

- Sweetwater Farms Hunter Jumper classes are run in accordance with the rules and specifications of the GSDHJA guidelines.
- All classes are recognized by the GSDHJA as listed in the GSDHJA specifications.
- Management:** The Horse Show Management reserves the right to interpret all questions and conditions in regards to or arising out of incident at the show without claims for damages or recourse of any kind. The Horse Show Management and their decision to be final shall decide all questions not covered in these regulations. The Horse Show Management reserves the right to refuse, accept conditionally, or cancel any entries, disqualify riders or exhibitors, prohibit exhibition of entries, and cancel award prizes without claim for damages, to change any course, to cancel or combine rings or rotate judges, to change specifications in jumper classes in order to facilitate the time schedule.
- Refunds and Scratches:** Class fees only will be refunded less a **\$6 fee per class office fee**, only in the case that the **office** (not gate) is notified **before** the start of the class that is being scratched. **No refunds** will be made if office is not notified of a scratch before the start of the class that is being scratch.
- Returned Checks:** There will be a penalty of \$25 for entries paid by check that is returned by the bank for any reason. To retain, both entries and penalties must be paid by money order, cashier's check or cash. Persons will be given 10 days after the show to settled their account, or be turned over to collections, USEF and GSDHJA for disciplinary actions. **Additionally, all local show managers will be notified that you bounce checks.**
- R.D.N.E.-** If an exhibitor rides but does not enter a class(es), rider is subject to a R.D.N.E. penalty of \$6 plus entry fee for that class or class(es).
- All applicable signatures on entry form are needed before a competitor will receive a competition number.**  
**See reverse of this page # 1.**
- Your signature** on the reverse side will also indicate your agreement to indemnify and save harmless the GSDHJA, board of directors, members, employees from and against any and all loss, cost or claim thereof.
- No horses are allowed to warm- up without a number. No exceptions.**
- Dogs** must be leashed and supervised. Dogs that create a problem will be required to leave the show grounds immediately.
- Tvina horses to ANYTHING on the showgrounds other than your horsetrailer is strictly forbidden.**
